The study points out that ancient paintings, sculptures and other art forms are full of representations of the ideal female figure. At the center of the study is the fact that throughout time and across cultures, the female buttocks has been a key feature that determines female beauty. Dr. Wright points out the study states that throughout history and with various cultures from around the world, an ample buttock area and a smaller waist have been considered beautiful.

In the study, published in the June issue of Plastic Reconstructive Surgery, Dr. Wendy Wong studied the characteristics of the aspects of the female buttocks considered to be the most attractive. The study surveyed 1,146 men and women, with an age range of 18 to 65-plus, with the 18 to 35 year category comprising the largest number of respondents.

The study revealed a change that showed that there was a preference toward an increased buttock size and hip to waist ratio. This change concerning what makes the most attractive buttocks illustrates a proven link to the increase in requests for enhancement surgeries, such as the Brazilian Butt Lift and fat transfer procedures.

### **Brazilian Butt Lift and Fat Transfer Procedures**
